ABSTRACT

PUSSY TOKEN is a social experiment that uses blockchain technology to demonstrate that it is possible to create a tool for storing and exchanging value only with the aim of a community that believes in the story connected to the project.

Bitcoin has disrupted the monetary system as we knew it. This new coin and the technology behind it brought the possibility to store and exchange value in a digital way without the need of any third party.

This new economy has no warranties, bitcoins have a value as long as the people who own them believe that it has this value. As long as new people develop an interest about it and are willing to pay to buy some bitcoins, the demand keeps growing faster than the supply and the price keeps growing.

This theory is not limited to bitcoin but it can be applied to almost every cryptocurrency. So, if a community of people believes in a determined digital asset, that is not duplicable and that has a finite number of pieces, this asset can be a store of value and can create a market connected to it.

Our idea is really simple:

most people who use cryptocurrencies are men aged between 25 and 35 years old. Our objective was to find something the majority of them believe in.

For sure, that thing is **PUSSY!**

So we decided to create the economics of pussy.

THE PUSSY SOCIAL EXPERIMENT

The project main asset is the **PUSSY TOKEN**. The idea behind it is to create a token backed by pussy.

Every person who believe in the power of pussy can buy **PUSSY TOKEN** and use it to store and exchange value with other people.

This token has a double meaning:

- on one side, it is a pure troll
- on the other side, it is the fundamental tool of this social experiment

The hypothesis is that with blockchain it is possible to build a new economy from scratch, connected to everything that a community of people is willing to believe in.

This is the extreme case: build a token that represents **PUSSY** and create a hole economy connected to it. If it's possible to create a **PUSSY ECONOMY** then it is possible to create any economy.

Starting with stats that show the common user of cryptocurrencies is a man aged between 25 and 35 years old we struggle to find the most common thing a person like that one believes in.

When we thought about pussy in the first moment we laughed very much, but then we understand that was the perfect way to validate our hypothesis.

PUSSY TOKEN is an instrument that, with the help of blockchain, let people all over the world realize they can be lastly financially free. Once the common people will understand that is possible to create a mean of value storage and exchange connected only to the idea of pussy, then they will understand that is possible to do this with everything else.

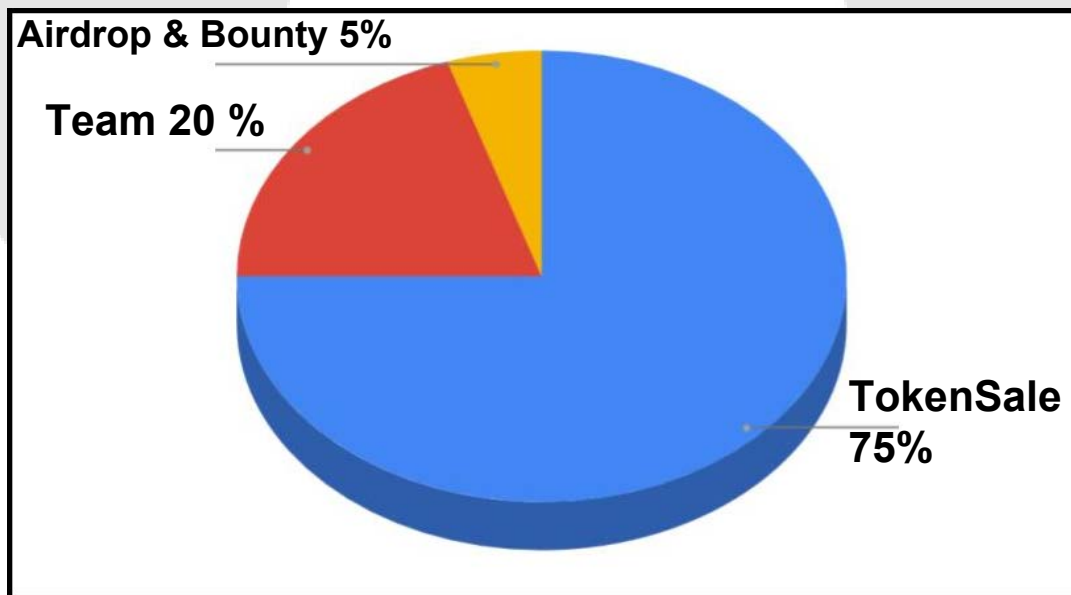
In our opinion it is possible to create an economy connected to everything, it could be trees, it could be archeological sites or it could be contemporary art. But what is more diffused and loved then pussy?

PUSSY TOKEN

Pussy Token is a standard ERC20 created on top of Ethereum Blockchain. The token symbol is **PUSSY**.

This token is a utility token that will be used to be part of the **PUSSY LOVERS RANKING**. Everyone who owns pussy token in his own wallet could be part of the ranking the shows users who has more pussy.

That ranking is already existing on our platform (pussytoken.io). We plan to improve the ranking and make it more interactive using Ether collected during the Token Sale.



The Total Supply of PUSY token is 999.999 PUSY.

The choice to create less than 1 Million token has a specific meaning. Find pussy is not so easy, and a good pussy is not a common thing, so PUSY TOKEN need to be rare.

Offer a limited supply of PUSY TOKEN is a mean to validate our hypothesis. In fact, the demand of pussy is always growing, so the demand of PUSY TOKEN should be the same. Acting in this way is useful to validate our hypothesis that is possible to create a new economy, that shares the growing value it generates between its participants.
